LETTER FROM THE EDITOR-IN-CHIEF

My Dear Friends and Colleagues:

It is once again a pleasure to bring the JSDA readership the summer 2017 issue which consists of articles covering economic, political, social and environmental concerns of sustainable development and the sustainability of African communities. The threats to political stability looms large in many African countries as they struggle with their efforts to find the right formulas to institute or establish democratic elections and government. Nigeria has been a good example to examine and to document its political progress. One of the papers in this issue does just that for the JSDA readership. Ethnicity problem in Africa have been an intractable one. Does it pose a problem for equitable distribution of resources and representation in national development efforts – particularly sustainable development? Nigeria has over 250 linguistic groups and they have to be properly represented in national government and properly funded for development through their own governments. One of the articles in this issue attempts to wrestle with this subject.

Environmental concerns are usually highlighted in the <u>JSDA</u>. In this issue, a Kenyan concern of predicting water demand and efficient use is tackled.

As usual, we believe that our readership would find the articles in this Summer 2017 issue interesting, informative, and instructive. We thank you for your continued support and suggestion.
